1. Shareholder Program Objective

2. Details

Eligible Shareholders

Ticket Information

Please note that there is a possibility that shareholders may not receive their tickets in time for a match because tickets may not be distributed to J.League top partners in a timely manner.

Application Process

Application for the lottery begins today, January 9, 2026. Please take note that the lottery schedule for matches to be held in February is condensed to ensure the shareholder program resumes as quickly as possible.

Application period: January 9 ~ January 14 Drawing: January 15

Late-February Matches

Application period: January 16 ~ January 21 Drawing: January 22

Early-March Matches

Application period: January 16 ~ January 31 Drawing: February 1
