## 2026 Ichigo J.League Shareholder Program Begins

### 1. Shareholder Program Objective

### 2. Details

#### Eligible Shareholders

All Ichigo Green shareholders recorded on the shareholder registry as of fiscal period-end are eligible for the Shareholder Program. All shareholders on record as of June 30, 2025 are currently eligible. Eligibility is updated every six months.

#### Ticket Information

Shareholders can simultaneously apply for tickets for one J1 League match and one J2/J3 League match even if the matches are scheduled on the same day. The tickets are freely transferable to family and friends.

Please note that there is a possibility that shareholders may not receive their tickets in time for a match because tickets may not be distributed to J.League top partners in a timely manner.

## Application Process

Application for the lottery begins today, January 9, 2026. Please take note that the lottery schedule for matches to be held in February is condensed to ensure the shareholder program resumes as quickly as possible.

### Early-February Matches

Application period: January 9 ~ January 14      Drawing: January 15

### Late-February Matches

Application period: January 16 ~ January 21      Drawing: January 22

### Early-March Matches

Application period: January 16 ~ January 31      Drawing: February 1
